Functions and performance levels:

(\*) the final level of the anti-slip features is achieved after the first hours of trial stage.

Marking:

on a stitched label and displaying the following information:

- CE Marking;
- Name of the Manufacturer (printed on the footwear);
- designation of the footwear (alphanumeric code: unique/unambiguous);
- nr. and year of the Standard of reference + safety symbols;
- size of footwear (also printed on the outsole);
- date of production (month + year);
- additional information: internal codes.
